Important Notes Key:

- 1. Your current account will be transitioned to Business Checking UNLESS you use the following Cash Management services (Remote Deposit Capture, Fax Wires, or Online Wires), then you will transition to Enhanced Business Checking. Please refer to page 22 in the enclosed Business Deposit Account Agreement for account features.
- 2. You will be charged for all services used. Please refer to the Business Fee Schedule in the Business Deposit Account Agreement for current business fees. This account does not earn interest but offers an earnings credit allowance (ECA) to offset service charges.
- 3. Your account will be transitioned to Enhanced Business Checking if you use Remote Deposit Capture, Fax Wires, or Online Wires, but do not use any other Cash Management services. Please refer to page 22 in the enclosed Business Deposit Account Agreement for account features.
- 4. A Relationship Manager will be contacting you separately if you are transitioning to Commercial Checking.
- 5. The name of this account type will be changing; however, the account features will remain the same.
